INSTRUCTIONS TO THE CANDIDATES APPEARING FOR THE POST OF

SENIOR ASSISTANT

1. Candidates shall report at the assigned Test Centre at least 1 hour before the commencement of the written Test.
2. Candidates are allowed to carry only the following items to the Examination Hall/ Room: a) Blue/ Black Ball Point Pen b) Admit Card c) Any valid Photo I.D. Proof and photographs d) Transparent Water Bottle
3. The candidates are not permitted to carry any communication devices like Cell Phone or any other Electronic Gadgets like Digital Watches, Mobile Phone, Bluetooth, Earphones, Pager, Health Band, Calculator etc. in the Examination Hall/Room. Analog watches may be allowed.

4. INSTRUCTIONS REGARDING OMR RESPONSE SHEET:

- i) Use only black/ blue ball point pen for writing the Roll No. /details on OMR Response Sheet and for shading the circles. The candidates are required to put his/her signature and fill all the details such as Roll number and Question Booklet Number in the space provided on the OMR Response Sheet. The descriptive part will be answer in the Answer Sheet only.
- ii) Test Paper will be in Two Parts (Part I and Part-II) of 200 marks which will be in English/Hindi:
 - a) Part-I: 100 Multiple Choice Questions for 100 marks (1 Marks each) to be answered in OMR Response Sheet.
 - b) Part-II: 05 Descriptive Question for 100 marks (20 Marks each) to be answered in Answer Sheet.
 - c) The language part consists of questions both in English and Hindi. Candidates have to answer only in one language i.e., English or Hindi and not both.
 - d) The candidate is required to select the most appropriate answer to each question. The answer circle should be shaded completely without leaving any space. Incomplete circles will not be evaluated.
 - e) Indicate only one answer by shading from the options provided. More than one response to a question shall be counted as 'wrong answer.
 - f) The Admit Card is provisional, subject to the verification of eligibility.
 - g) The candidates are required to check all the pages and questions in their Question Booklet before starting to mark the answers. If something is missing or not properly printed, or is damaged, request should be made to the invigilator immediately to give another Sealed new Question Booklet.
 - h) As the OMR Response Sheet is carbonized, the candidates shall detach the second page (carbon copy) of OMR Response Sheet and keep it with them for reference along with used Question Booklet. The first page of OMR Response Sheet (Original) shall be submitted to the invigilator at the end of the Entrance Test.
 - i) **THERE WILL NOT BE ANY NEGATIVE MARKING IN THE TEST.**
 - j) If there is any difference between English and Hindi questions, please follow English questions only.
