**Call for Applications for Consultant (Designer) for Project 39A**

The National Law University Delhi ('University') is seeking to engage one 'Consultant – Designer' on a three (3) month contractual basis, for Project 39A. The consultant will be responsible for publication design, including illustrations of a research study on the role of magistrates in ensuring constitutional protections.

**About the Organisation:**

Project 39A draws inspiration from Article 39-A in the Indian Constitution on equal justice and opportunity in the legal system. We work on issues specific to the criminal justice system, and undertake pro bono litigation, research and outreach relating to prevention of torture, legal aid, forensics, death penalty, and mental health and criminal justice (for more information on Project 39A, visit [www.project39a.com](http://www.project39a.com)).

**Responsibilities:**

The designer is expected to:

- A. Develop and implement the design and visual language of the report on the role of magistrates in ensuring constitutional protections.
- B. Create and work on illustrations / graphics suitable for the report.
- C. Finalise the design and illustrations/graphics/tables for the report based on feedback and in coordination with the staff.
- D. Create a web version of the report
- E. Suggest the printing specifications for the report that bring out the best product.
- F. Coordinate with the identified printer till the production and printing of the final report.
- G. Undertake any other work that may be necessary to fulfill the report designing objective.

**Qualifications:**

- A. Extensive body of work and experience as a visual artist, illustrator and graphic designer.
- B. Experience in publication design with ambitious production value.
- C. Undergraduate/ graduate degree in design and allied fields from a reputed, national design college.

F. Preferably having won industry accolades in the domain of book design.

**Compensation:** Remuneration will be commensurate with qualifications and experience. The duration of the contract currently will be three (3) months. The contract may be terminated by the University before the completion of three (3) months or may be extended as required.
