The National Law University, Delhi ('University') is seeking to engage **one Consultant (Designer)** to work with and further the aims of Project 39A ('Project'). The contract will be for a period of 4 months.

About the Project: Project 39A draws inspiration from Article 39-A in the Indian Constitution on equal justice and signals the broadening of our engagement with the criminal justice system in India. The Project undertakes litigation, research and outreach relating to forensics, torture, legal aid, forensic psychiatry and death penalty (for more information on Project 39A, visit www.project39a.com). Project 39A is headed by the Executive Director, Dr. Anup Surendranath (Assistant Professor of Law, National Law University Delhi) and has 12 full-time associates involved in litigation, mitigation, research and public outreach.

Given the project's expansive work across research, litigation and public outreach, there is a continuous requirement for the designing of reports, brochures, event collaterals and publications. The Project is seeking to hire one designer as a consultant for designing the report of a project on sentencing in trial courts of Maharashtra, Madhya Pradesh and Delhi in death penalty cases.

Responsibilities:

- A. Design the Project's research publication on sentencing in death penalty cases.
- B. Coordinate with the identified printers till the production of final product.
- C. Undertake any other work that may be necessary to fulfill the Project's objectives.

Qualifications:

- A. Graduate in graphic and communication design from a reputed institution
- B. Minimum three years' experience of working with a reputed graphic design firm
- C. Prior experience of conceptualising and designing social science materials would be preferred

Compensation: Remuneration will be commensurate with qualifications and experience and will be approximately in the range of Rs. 50,000-55,000 per month.

Duration of the Contract: The contract will be for a period of 4 months. An extension may be possible subject to the availability of funds.

Application Process: Interested persons may send their resume and portfolio of their work.
