## **CALL FOR PAPERS- INAUGURAL ISSUE OF 'JOURNAL OF VICTIMOLOGY & VICTIM JUSTICE'**

Anchored at the National Law University, Delhi under the aegis of Indian Society of Victimology (ISV) the Journal of Victimology & Victim Justice is envisaged to be the flagship publication of ISV. It invites scholarly writings including articles, notes and comments from academicians, victim service providers, policy makers, scholars and students. ## **THE INDIAN SOCIETY OF VICTIMOLOGY**

The ISV was established in August 1992 and was formally inaugurated by the eminent jurist Hon'ble Mr. Justice V.R. Krishna Iyer, Former Judge of the Supreme Court of India, in September 1992 through the efforts of the then Head of the Department Prof. K. Chockalingam in the University of Madras. The ISV was established with the objective of advocating the cause of victims of crime and abuse of power in India and to some extent it has been realized. As of today, it has about 400 members. During the last 22 years, the ISV has organized several symposia, seminars, and conferences on various victimological issues. One of the significant contributions of the ISV was the preparation of draft victim legislation, with the support of the National Law School of India University, Bangalore, and the National Human Rights Commission in 1996 through an intensive workshop organized in Chennai. The Committee on the Reforms of Criminal Justice System constituted by the Government of India, Ministry of Home Affairs, in November 2000 to consider measures for revamping the criminal justice system also recommended the draft bill prepared by ISV for consideration. Even for the introduction of the State Victim Assistance Fund by the Government of Tamil Nadu in 1995, the ISV served as a catalyst. The dream of ISV to have a national-level victim compensation law through its recommendation in a seminar on victim compensation as early as in 1993 has been realized by the introduction of the provisions of victim compensation throughout India through the Criminal Law Amendment Act, 2008. Therefore, with a sense of humility, the ISV feels proud that the victim rights as enshrined in the UN Declaration of Victims, 1985, are gradually

becoming a reality in India. Presently, the Indian Society of Victimology is chaired by Prof. (Dr.) G.S. Bajpai, Registrar, National Law University Delhi with Dr. M. Priyamvada, Indian Society of Victimology, University of Madras, as a General Secretary.

### ABOUT THE JOURNAL:

The Journal is the flagship journal of the Indian Society of Victimology (ISV) The Journal will include Articles, Notes and Comments from eminent jurists, academicians, victim service providers, policy makers, scholars and students. Focussing both on critical leadership and practical development, the articles will reflect victimological perspectives from a broad range of disciplines and contribute to a greater understanding of victims, victimization, victim offender relations, institutional functioning and allied issues. The journal will deploy the insights and methodologies of all relevant disciplines including psychology, psychiatry, sociology, social work, economic, history as well as law and legal and political theory to further the interests of victims all across the world. The Journal will be a peer-reviewed journal with two issues published annually.

### MANUSCRIPT STRUCTURE:

#### *Length of Papers*

Articles: 8000-10000 words

Short Articles: 5000-8000 words

Notes: 1000-3000 words

Case Comments: 1000-3000 words

In exceptional cases, shorter or longer pieces of writing may be considered.

#### *Language*

Manuscripts should be written in British English. Spelling should be consistent throughout.

Articles must be typed, double-spaced throughout on A4 paper in Times Roman font, allowing good margins.

#### *Abstract and Keywords*

On the first page of the manuscript after the title and author's name and affiliation, articles should include a short abstract, consisting of only one paragraph (100-150 words) as well as

3-10 keywords.

#### Headings

All headings should be flush left and should be numbered:

1 First Level Headings Are in Bold

1.1 Second Level Headings Are Bold Italic

1.1.1 Third Level Headings Are Roman

#### Quotations

Always use single quotation marks (") for relatively short direct quotations.

Longer quotations should be presented as a separate block of text, indented on the left, preceded and followed by a blank line, and printed in characters of normal size; such longer quotations are *not* enclosed in quotation marks.

Double quotation marks (") are reserved for single words, concepts or short phrases that are not a quotation. Quotation marks should always precede punctuation marks.

#### Citation style

Manuscripts should be prepared following the APA (American Psychological Association) 6<sup>th</sup> Edition format only; any other style will not be entertained.

### MANUSCRIPT SUBMISSION:

All manuscripts must be sent in doc. format through email to [editor.isvjournal@nludelhi.ac.in](mailto:editor.isvjournal@nludelhi.ac.in). It must be accompanied by a cover letter mentioning the name of author, designation, institutional/ contact details, theme of the paper etc.

### LAST DATE OF SUBMITTING ARTICLES FOR INAUGURAL ISSUE:

All articles must reach the editor on or before 20<sup>th</sup> January, 2018.
