CALL FOR APPLICATIONS FOR RESEARCH FELLOW

About Centre for Law, Justice and Development (CLJD): As a research centre under the aegis of a university that believes in imparting interdisciplinary legal education, Centre for Law Justice and Development engages with issues that meet at the confluence of legal and development discourses. It seeks to revisit, analyse and critique the existing socio-legal structures to enable alternative interpretations and implementation of law in development. Such an engagement is envisaged to be more inclusive to march towards securing justice for all.

Through the various projects and events that CLJD is undertaking and has organized, it ensures that it has a wide array of activities, spanning across field work, doctrinal research and capacity building and literacy programmes.

Area of work: CLJD is currently engaged in projects relating to human rights, gender justice, education and tribal rights. Pursuant to these research activities, CLJD is looking for a research fellow to perform the following tasks:

- i) provide research support for ongoing projects;
- ii) research and compile information on specific areas and topics, when needed;
- iii) assist in documentation and preparation of project reports and Centre publications;
- iv) provide logistical and administrative support for Centre's activities and initiatives; and
- v) assist with other related tasks as needed

Eligibility Requirement: Prospective applicants must possess the following qualifications:

- i. a five-year/ three-year LL.B degree with at least 2 year work experience or LL.M. degree
- ii. 1 - 2 year work experience in socio-legal research (desirable);
- iii. demonstrate good research and writing skills;
- iv. demonstrate good oral and written communication skills; and
- v. good knowledge of MS office and online platforms

Application Requirement:

- i. Curriculum Vitae, **not exceeding two side A-4 sheet;**
- ii. Statement of Purpose, **max. 500 words;**

- iii. Writing sample, **max 1000 words** (unless it is a published article in a reputed journal in which case this word limit does not apply);

Process: All applications must be submitted through the google form latest by 5th August, 2022 (Friday 5.00pm).
