Research Associate (Law):

The Research Associate is expected to engage in diverse research activities including collection and compilation of research material, field work, data collection, data analysis, report drafting, etc. He/she is expected to assist the principal investigator in conducting research on various themes/projects.

Who can Apply

Candidates holding post-graduate degree in law (LL.M. with 55% marks minimum) having interest and experience in empirical and doctrinal research in interdisciplinary fields.

Candidate should be below the age of 40 years at the time of appointment.

Essential Qualifications

- possess a post-graduate degree in law with minimum 55% marks;
- demonstrate good field research skills and experience
- demonstrate good oral and written communication skills;
- ability to create quality content, worth publication; and
- good knowledge of MS office and online platforms

Doctrinal and Empirical research in Indian justice delivery system, comparative constitutional law, content creation, publication and other research assignments of the Centre

Duration

The position is for an initial period of 6 months, which can be extended to one year based on satisfactory performance.

The contract may be further extended depending on the performance of the candidate.
