## Objective:

There is a dire need to complement the awarding of formal degrees in the Higher Education sector with thematic and specialised courses with the fluidity to constantly adapt to changing parameters. It is especially true in case of environment as a subject as it has constantly changing dimensions and is an amalgamation of several areas including law, science and technology and socio-economic narratives. Centre for Environmental Law, Policy and Research (CELPR) at NLU Delhi will be commencing two law-centric PG online diploma courses namely **Energy and Sustainability Laws** and **Enviro-Legal Regime of SDGs in India**. Such specialised courses will not only provide prudent and relevant knowledge to law students on key environmental issues in specific areas but also to other stakeholders that may have particular inclination in the specific themes. These courses assume special significance in view of the ongoing crisis that is disruptive of classroom teaching and is warranting innovative courses on the digital platform.

## Learning Outcomes:

- Broad understanding of environmental law and policy at the national and international level.
- Comprehensive knowledge about the key substantive areas within each of the themes as part of each of the Courses.
- Understanding the interrelationship with sustainability and their impact on human life and environment.
- Theoretical and practical aspects of contemporary environmental issues

**Number of Seats:** The total number of seats for each course will be 80. However, the Centre reserves the right to alter the number of seats in each course without prior notice.

**Reservation of Seats:** 22% for OBC candidates (Non creamy layer), 15% for SC candidates, 7.5 % for ST candidates, 10% for EWS candidates and 5% horizontal reservation of seats for Persons with Disabilities. Students

availing reservation need to send the required certificates along with the application form.

*100% Scholarship available for two students belonging from Below Poverty Line Families.*

**Admission Criteria:** Prospective students need to fill an Application form and send their transcripts (Class X and Class XII marksheet, College Degree/marksheets), Statement of Purpose [maximum 500 words] and Relevant Experience. Based on the above-mentioned documents, students will be selected for the courses. However, CELPR Admission Board reserves the final right regarding admission to the courses. **For successful submission of the application, prospective students are required to fill the detailed application form along with the Google form. (Link for which, is provided in the application form)**

**Eligibility:** Graduate in any stream with a minimum of 55% marks.

**Fees:** The tuition fee for the course is Rs. 60,000 (Sixty Thousand only) for Indian Nationals. For Foreign nationals, the tuition fee is USD 1500. Registration fee: Rs. 3,000

**Duration for the Course:** The online course will be for a period of One Academic year (October 2020 - August 2021). Online Contact classes will be conducted for the entire course covering various modules.

**Subject Experts:** Each module has been designed in order to provide subjective and practical overview of the contemporary issues at hand at International and National level. In order to maintain highest standards and to provide quality learning experience each module will be taught in live online session by a resource person having expertise knowledge in the specialized field to be dealt with. Special lectures by legal luminaries.

## Course Structure:

Each course is divided in two semesters of 12 credits each. There will be a total of Nine modules and One Research paper.

For each module there will be eight contact classes of one hour each to be conducted on weekends fortnightly including doubt clearing sessions.

### Marking Scheme:

Total marks for each module: 100. Each module shall carry an internal assessment of 45 marks. There shall be End Semester examination of 50 marks for each module. 5 marks in each module have been allocated for attendance.

Total marks for Research Paper:100

### **Evaluation:**

Completion certificate for the course will be provided only to those students who have secured at least 40 marks out of 100 (including internal assessment, end term examination and attendance) in each of the modules and the Research paper.

### **Grading of students:**

The performance of students will be graded on a 10 Pt. scale with the corresponding grade values as follows:

### **Examination Scheme:**

In the first semester there will be five modules. Second semester will consist of four modules and a Research paper which the students will be required to write demonstrating their academic knowledge and research skills gained throughout the course.

It shall be mandatory for every student to appear for every examination conducted by the CELPR, NLU Delhi. A student who absents himself/herself for an examination shall be declared "Failed" in that course.

One opportunity will be provided to students who have failed/not attempted in a particular module, to give the end- semester examination again. If he/she passes the module in the next attempt, the grade obtained shall have (R) mentioned against it in the transcript. Additional fees of Rs. 2,500/- shall be charged per module for students reregistering to appear for examinations again.

In view of the nature of the course, students are expected to possess the requisite cyber equipment such as laptop or desktop with webcam and the skills of using on-line, audio-visual, virtual and other forms of technical medium.

The Vice Chancellor of the National Law University, Delhi shall have the power to ease any complexity and resolve problems in the conduct of these courses
